SUMMARY

- The Offer Price has been determined to be HK\$0.55 per Offer Share plus brokerage of 1%, SFC transaction levy of 0.003% and Stock Exchange trading fee of 0.005%.
- Based on the Offer Price of HK\$0.55 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other related listing expenses payable by the Company in the Share Offer, is estimated to be approximately HK\$77.6 million. For details regarding the use of net proceeds, please refer to the paragraph headed “Offer Price and use of net proceeds from the Share Offer” below.
- A total of 10,685 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms for a total of 11,142,760,000 Public Offer Shares, equivalent to approximately 557 times of the total number of 20,000,000 Public Offer Shares initially available under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the re-allocation procedures as described in the section headed “Structure of the Share Offer — Re-allocation of Offer Shares between the Public Offer and the Placing” in the Prospectus have been applied. Based on the Offer Price of HK\$0.55 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deduction of the underwriting commissions and other related listing expenses payable by the Company in the Share Offer, is estimated to be approximately HK\$77.6 million.
